release unto CHARLSIE C. PARKS, her heirs and assigns forever:

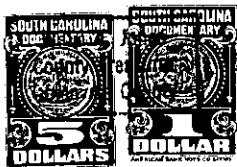
All that certain piece, parcel or lot of land being known and designated as
