KNOW ALL MEN BY THESE PRESENTS, that --John H. Thompson-----

in consideration of -----One and No/100 (\$1.00) and partition of property----- Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Varon T. Bagwell, her heirs and assigns:

All my right, title and interest in and to all that piece, parcel or tract of land, lying and being situate on the easterly side of Thompson Road (S. C. Highway 23-93) in O'Neal Township, County of Greenville, State of South Carolina and having according to plat of "Property of B. D. Thompson Estate" by Terry T. Dill, C. E. and L. S. dated February 23, 1935 as revised on January 4, 1968, the following metes and bounds to wit:

BEGINNING at an iron pin in the center of Thompson Road at joint corner of property of the grantor and grantee with that of J. W. Greer Estate (or formerly) and running thence along the center of said Thompson Road N. 15-00 E. 100 feet to a point; thence further along the center of said Road N. 10-00 E. 33 feet to a point in said Road; thence S. 75-00 E. 300 feet to an iron pin; thence S. 51-50 E. 1055 feet to an iron pin in branch; thence with the branch as the line, the traverse line of which is S. 48-45 W. 239 feet to an iron pin; thence S. 59-30 W. 575 feet to a stone on the easterly boundary of J. W. Greer property (or formerly); thence along said boundary N. 30-45 W. 1167 feet to a point in the center of said Thompson Road at the point of beginning and containing according to said plat 12.90 acres.

The herein named grantee is to pay the 1969 taxes on the above described property. The above described property is subject to existing easements, rights of way and reservations. The above described property is a portion of a larger tract formerly owned by Bryson D. Thompson who died testate in Greenville County, South Carolina on October 8, 1963 as shown in Apartment 845, File 23, records of the Probate Court for Greenville County, South Carolina and is identified on the Greenville County Block Book as part of Lot 5, Block 1, Page 648.6, in School District 320.

This deed represents the division of a tract of 25.6 acres, more or less, conveyed to the grantor and grantee by deed of W. C. Thompson recorded in Deed Vol. 805 at Page 65, R.M.C. Office.
