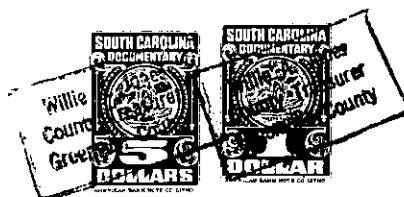
KNOW ALL MEN BY THESE PRESENTS, that I, Beulah W. Garrison,
