the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release  
unto

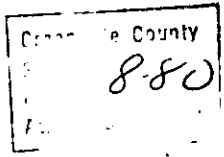
J. C. Cantrell and Viola Cantrell, their heirs and assigns forever:

All that certain piece, parcel, or lot of land, with all improvements thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the eastern side of Brighton Lane, being known and designated as Lot No. 57 of a subdivision known as Colonial Hills, according to a plat prepared by Piedmont Engineers & Architects, dated April 24, 1964, and recorded in the R. M. C. Office for Greenville County in Plat Book FFF, at Page 102, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the eastern side of Brighton Lane, joint front corner of Lots 56 and 57, and running thence with the joint line of said lots, S. 82-49 E. 169.1 feet to an iron pin, joint rear corner of said lots; thence along the rear of Lots 57 and 59, N. 8-59 W. 96.9 feet to an iron pin, joint rear corner of Lots 57 and 58; thence with the joint line of said lots, N. 55-35 W. 123.2 feet to an iron pin on the eastern side of Brighton Lane; thence with said lane, following the curvature thereof, the chords being S. 29-53 W. 49.0 feet, S. 22-10 W. 56.2 feet, S. 6-06 W. 50.0 feet, to an iron pin, joint front corner of Lots 56 and 57, the point of beginning.

This conveyance is made subject to any restrictions or easements that may appear of record, on the recorded plat(s), or on the premises.

As a part of the consideration for this conveyance, the grantees expressly assume and agree to pay the balance due on that certain note and mortgage, in the original sum of \$11,000.00 executed by J. P. Medlock to the First Federal Savings and Loan Association of Greenville and recorded in the R. M. C. Office for Greenville County in Mortgage Book 994, at Page 598, the balance due thereon being the sum of \$9,985.90 as of this date.
