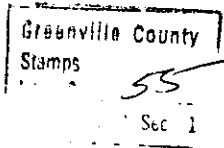
KNOW ALL MEN BY THESE PRESENTS, that I, J. H. Mauldin, of Greenville County,

All that certain piece, parcel, or lot of land situate, lying and being in the State of South Carolina, County of Greenville, as is more fully shown on a plat of property of J. H. Mauldin dated September, 1962 and prepared by C. C. Jones, Civil Engineer, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin at the joint rear corner of Lots Nos. 4 and 5, Mauldin Meadows Subdivision as recorded in the R. M. C. Office for Greenville County in Plat Book EE, at Page 151, and running thence with the rear line of Lot No. 5, N. 26-15 E. 80 feet to an iron pin at the joint rear corner of Lots Nos. 5 and 6; and running thence S. 63-45 E. 83 feet, more or less, to a point; running thence S. 23-39 W. 24 feet to an iron pin; running thence S. 15-17 W. 56 feet to a point; running thence N. 63-45 W. 96 feet to the point of beginning.
