	Within 5 days after receipt of this Notice, you must notify the Town of Travelers Rest, in writing the names of the two free-holders that you select. Upon your failure to do so the Clark of Court shall represent the second of the two free-holders that you select.
	The four freeholders shall, within 5 days, select a fifth freeholder; upon their failure to do so, the Clerk of Court shall so select. The five freeholders shall then fix the value of any real estate or assess any damages, if any, due the landowner(s). They shall agree, then the award shall be by a majority, in writing, to the Clerk of Court. The five freeholders must serve a copy of the "award" upon the Town, the landowner and lienholders.
	Within 10 days after receipt of the "award," the Town or landowner may appeal unto the Court of Common Pleas. If an award is made to the landowner, the Town may deposit said amount with the Clerk of Court and immediately take the property or right-of-way and proceed with the project.
