KNOW ALL MEN BY THESE PRESENTS, that I, PAUL R. LONG,

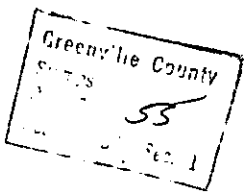
in consideration of THREE HUNDRED FIFTY AND NO/100 (\$350.00) ----- Dollars,
