AND CORRECTION OF DEED  
the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release  
unto Robert L. Murphy and Lorine F. Murphy, their heirs and assigns, forever:

All that piece, parcel or lot of land in the County of Greenville, State of South Carolina situate, lying and being on the northwestern side of Perry Road and being known and designated as Lot No. 5 on Plat of the Property of Ethel Y. Perry Estate, plat of which is recorded in the RMC Office of Greenville County in Plat Book "Q", at Page 24 and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the northwestern side of Perry Road, joint front corner of Lot Nos. 4 and 5 and running thence with the common line of said lots N. 47-00 W. 119 feet to an iron pin; thence N. 43-00 E. 55 feet to an iron pin; thence S. 47-00 E. 119 feet to an iron pin on the northwestern side of Perry Road; thence with said Road S. 43-00 W. 55 feet to an iron pin, the point of beginning.

This is the same property conveyed to the Grantees by deed of Melvin Martin Griffin and Nancy Sue Griffin dated May 15, 1970 as recorded in the RMC Office for Greenville County in Deed Book 891, at Page 316. This conveyance is made subject to restrictions, easements and rights-of-way appearing on record in the RMC Office for Greenville County.

As a part of the consideration the grantees assume and agree to pay that certain mortgage given to United Mortgagee Servicing Corporation as recorded in the RMC Office for Greenville County in the original amount of \$12,850.00 and having a present balance of \$12,300.00.

And, the grantor(s) do(es) hereby bind the grantor(s) and the grantor(s)' heirs or successors, executors and administrators to warrant and forever defend all and singular said premises unto the grantee(s) and the grantee(s)' heirs or successors and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
