the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release
unto Harold R. Bridges, his heirs and assigns forever:

ALL that piece, parcel or lot of land, with the buildings and improvements thereon, situate, lying and being near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot 50, on Flat of Sans Souci Heights, plat of which is recorded in the RMC Office for Greenville County, South Carolina, in Plat Book Y, page 25, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northeasterly side of Earnshaw Avenue, joint front corner Lots 49 and 50, said iron pin being 145.3 feet in a southeasterly direction from the intersection of Skyland Avenue and Earnshaw Avenue; and running thence N. 62-41 E. 126.8 feet to an iron pin; thence S. 39-10 E. 70 feet to an iron pin; thence S. 63-07 W. 132.8 feet to an iron pin on Earnshaw Avenue, joint front corner Lots 50 and 51; thence along Earnshaw Avenue N. 35-35 W. 69 feet to an iron pin, the point of beginning.

As a part of the consideration hereof, the Grantee agrees to assume and pay, according to its terms, that certain note and mortgage given to Cameron-Brown Company on which there is a balance due of \$8281.20; said mortgage being recorded in Mortgages Volume 883 at page 33.
