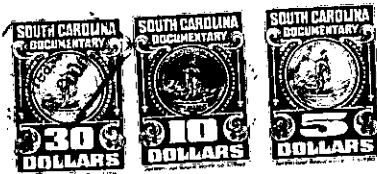
KNOW ALL MEN BY THESE PRESENTS, that Doris L. Beedie -----
