the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Thomas C. Holmes and Virginia L. Holmes, their heirs and assigns, forever:

ALL our right, title and interest in and to all that certain piece, parcel or lot of land with all improvements thereon situate, lying and being on the Southwest side of Worley Road, in the County of Greenville, State of South Carolina, having, according to a survey of the said property made by Jones Engineering Services in June, 1970, the following description:

Beginning at an iron pin or point in the center of Worley Road, corner with property now or formerly owned by Norman K. Miles, and running thence with the center of said Worley Road, S. 34-17 E. 50 feet to a point; thence still with said Worley Road S. 25-27 E., 165.7 feet to an iron pin; thence leaving Worley Road and running S. 71-52 W., 501 feet to an iron pin; thence N. 8-03 E., 364 feet to an iron pin; thence S. 61-30 E., 250.5 feet to an iron pin; thence N. 45-00 E., 150 feet to the point and place of beginning.
