the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto The City of Greenville, a Municipal Corporation, P.O. Box 2207, Greenville, SC 29602, its successors and assigns:

ALL that piece, parcel or lot of land lying and being situate in the City of Greenville, County and State aforesaid, lying on the eastern side of McAlister Road and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the eastern side of McAlister Road, said pin being a distance of 1,089.1 feet, more or less, South of the intersection of McAlister Road and LeGrand Boulevard and running thence N. 61-40 W. 13 feet, more or less, to a pin on McAlister Road; thence running along McAlister Road, N. 28-20 E. 140 feet, more or less, to an iron pin; thence S. 61-40 E. 13 feet, more or less, to an iron pin, a new 50 foot right-of-way; thence S. 28-20 W. 140 feet, more or less, to the beginning corner.
