ALL that certain piece, parcel or lot of land in Paris Mountain Township, Greenville County, State of S.C., lying and being on the eastern side of Cambridge Ave., containing 0.77 acres, more or less, and being described according to a plat by Pickell & Pickell, Engineers, dated April 28, 1951, as follows:

BEGINNING at an iron pin on the eastern side of Cambridge Avenue at corner of other property of George W.
