This Indenture made this Nineteenth of May in the year of our Lord one thousand seven hundred and Eighty Eight Between Benjamin Clark of the one part and Benjamin Merit of the other part both of the state of South Carolina and Ninety six District Witnesseth that the said Benjamin Clark for and in consideration of the sum of two hundred pounds Sterling to him in hand paid by the said Benjamin Merit at or before the sealing and Delivery of these presents the Receipt and payment whereof is hereby fully Acknowledged, He the said Benjamin Clark hath Given Granted bargained and sold and by these presents Doth Give, Grant bargain and Sell alien and Release Convey and Confer unto the said Benjamin Merit his heirs and assigns forever a certain tract or parcel of land situate lying and being in the state and District aforesaid and on the north fork of Saluda River including the old town house, cutting and bounding as will more fully appear by a plat annexed to the Grant of said Land containing two hundred acres, be the same more or less being a tract Granted said Clark bearing date the twenty first of January one thousand seven hundred and Eighty five and in the Ninth Year of American Independence and duly Recorded in the Secretarys Office as by Reference thereunto had may fully and at large appear Together with all and singular the Woods Ways Waters Watercourses, Buildings, Improv-
