South Carolina Greenville County August the Eighteenth One Thousand Seven hundred and Eighty Eight Release and Release for one hundred acres of land from Jesse Moody to Joseph Meacham, proved by the oath of James West in open Court and Order to be Recorded



This Indenture made the Ninth day of February and in the year of our Lord One Thousand Seven hundred and Eighty Seven and in the twelfth year of the Independence of the United States of America Between Jesse Moody of Greenville County and State of South Carolina planter of the one part, and Joseph Meacham of the State and County of Greene planter of the other part, Witnessed that the said Jesse Moody for and in consideration of the sum of Ten pounds Sterling to him in hand well and truly paid by the said Joseph Meacham stand before the Sealing and Delivery of these presents the Receipt whereof is hereby acknowledged, he the said Jesse Moody hath bargained and sold and by these presents doth bargain and sell unto the said Joseph Meacham all that plantation or Tract of land containing one hundred acres more or less being and lying in the County aforesaid on a branch of the Golden Grove Creek waters of Saluda River it being part of a tract of land containing four hundred acres granted unto Benjamin Rice by his Excellency Benjamin Guerard Esquire Governor the fifteenth day of October One Thousand seven hundred and Eighty four and in the ninth

year of the Independence of the United States of America. Together with all and singular the houses, Out houses, Eriques, Buildings, barns, Stables, yards, Gardens, Orchards, Woods, underwoods, Timber and Timber trees, Meadows, pastures, ponds, Lakes, fishings ways, waters and water courses, paths, passages, Liberties, privileges profits, Hereditaments, Rights, Members and appurtenances whatsoever, thereunto belonging, or in anywise appertaining, and the Reversion, or Reversions Remainder and Remainders, Rents, Issues and profits thereof, and of every part and parcel thereof, To have and to hold, the said plantation or Tract of land containing One hundred acres more or less, with every the premises and appurtenances thereunto belonging unto the said Joseph Meacham his heirs Executors Administrators and assigns from the day next before the day of the of these presents for and during and until the end and Term of One whole year from thence next ensuing and fully to be completed and ended yielding and paying therefore unto the said Jesse Moody the rent of One penny per acre on the Last day of the said term of the same shall be lawfully demanded to the Intent and purpose that by Virtue of these and by force of the Statute for transferring of uses into possession he the said Joseph Meacham may be in actual possession of all and singular the premises above mentioned with every the appurtenances thereunto belonging and thereby be the better enabled to have take and Receive the Reversion and Inheritance thereof which is Intended to be to him and his heirs granted and Released by the said Jesse Moody, by another Indenture Intended to be made and dated the day next after the day of the date hereof In Witness whereof the above named Jesse Moody hath hereunto set his hand and seal the day and date above written.
