6 This Indenture made this fifth day of February One Thousand Seven hundred and Eighty Nine, Between Hewlet Swillivant of Ninety Six District and Greenville County of the one part and Pleasant Swillivant of the same place of the other part, Noteth Both that the said Hewlet Swillivant for and in consideration of the sum of Twenty pounds Sterling money of the State aforesaid to him in hand paid at and before the sealing and delivery of these presents the receipt whereof he doth hereby acknowledge hath granted bargained sold aliened Remised Released and Confirmed unto the said Pleasant Swillivant in his actual possession now being by virtue of a bargain and sale to him thereof made for one whole year by Indenture of Lease bearing date next the day next before the day of the date hereof and by virtue and force of the Statute for transferring of uses into possession and to his heirs and assigns all that Tract of land containing two hundred and sixty acres situate lying and being on a branch of the Little Reedy fork of Reedy River Ninety Six District Greenville County bounded on the North sides by land belonging to Mr. Beale, and all other sides vacant when surveyed granted unto the said Hewlet Swillivant by the States letter Patent under the hand of William Moultrie then Governor bearing date the first day of May, One Thousand Seven hundred and Eighty Six and hath such shape form and marks as the plat thereof directs to the Original Grant annexed, Together with all and singular that Tract of land said land whereon the said Pleasant now resides, the ways wells watercourses easements profits Commodities Advantages Emoluments Hereditaments and appertenances whatsoever to the said land belonging or any wise appertaining and the reversion and reversions remainder and remainders rents uses and profits thereof and also all the Estate right title Interest possession property claim and demand whatsoever either in Law or Equity of the said Hewlet Swillivant of into or out of the said premises To Have and To Hold the said tract of land be the same more or less hereby granted and released with their appurtenances unto the said Pleasant Swillivant his heirs and assigns forever, and the said Hewlet Swillivant for himself his heirs and assigns do covenant and grant and agree to and with the said Pleasant Swillivant his heirs and assigns by these presents that it shall and may be.
