A Deed of conveyance for two hundred and thirty three acres of land from Obadiah Hooper to John Childers, proved by the oath of George Johnson & Robert Childers in open court and ordered to be recorded.

This Indenture made the thirteenth day of December in the year of our Lord One Thousand Seven hundred and Eighty Eight Between Obadiah Hooper of Greenville County and State aforesaid of the one part and John Childers of the said County of the other part Witnesseth that the said Obadiah Hooper for and in consideration of the sum of twenty pounds current money of said State to him the said Obadiah Hooper in hand well and truly paid by the said John Childers the receipt whereof is hereby acknowledged he the said Obadiah Hooper hath granted bargained, sold aliened conveyed and confirmed and by these presents doth grant bargain sell alien release convey and confirm unto the said John Childers his heirs and assigns forever in his actual possession now being a tract of land containing two hundred and thirty three acres the same being granted to the said Obadiah Hooper under the hand of William Moultrie Esq Governor and the great seal of the said State thereof affixed and duly recorded in the Secretary office of said State, and dated the fifth day of February 1787 relation being thereunto had may appear Situate on both sides of Beaver-dam Creek of S.
