This Indenture Made this twenty third day of February in the Year of our Lord One Thousand seven hundred and Eighty seven and in the Eleventh year of our Independence Between James Bates of the State of South Carolina and district of Ninety six and Greenville County of the one part, and Moses Shann of the State and district aforesaid and Greenville County of the other part. Whereas in and by a certain Grant bearing date the twenty first day of January One Thousand seven hundred and Eighty five from under the hand of his Excellency Benjamin Guerard Esquire Governour for the time being and the great seal of this State for that purpose appointed did give and Grant unto James Bates a certain tract of one hundred and fifty Acres of Land, Situate and lying on both sides of South Pacolate River, all sides on vacant Land when Surveyed and hath such shape form and marks as appears by a plat to the said Grant annexed the said plat and Grant being duly recorded in the secretaries office. Witnesseth that the said James Bates for and in consideration of the sum of Thirty Pounds current Money to him the said James Bates in hand well and truly paid the receipt whereof is hereby acknowledged he the said James Bates hath granted bargained and sold and by these presents doth Grant bargain and sell unto the said Moses Shann his heirs and assigns one hundred and one Acres of Land it being more or less beginning on a red Oak station thence East twenty four Chains to a red Oak Corner thence South across south Pacolate River fifteen Chains to a red Oak Station thirty eight Chain and twenty two links to a red Oak Corner thence West fourteen Chain and fifty links to a Maple station on a branch running in twenty six Chain to a small red Oak thence across said River to the beginning, and all trees, woods underwoods, tithes, Commons, and Common of pasture ways, water-courses, profits Commodities, Advantages Hereditaments and appertinances whatsoever to the said tract above mentioned belonging or in anywise appertaining and the Reversion and Reversions, Remainder and Remainders, Rents, Issues and Profits of the said premises and every part and parcel thereof and all the Estate, right title Intrust claim and demand of him the said James Bates of in and to the said tract of one hundred and one Acres of Land and premises and every part thereof.
