This Indenture Made the Eighth day of January in the Year of our Lord One Thousand seven hundred and Eighty Nine. Between Josiah Culbertson of Spartanburgh County and State of South Carolina of the one part. and John Thomas Junior of Greenville County and State aforesaid of the other part. Witnesseth that the said Josiah Culbertson for and in Consideration of the of Three hundred Pounds Sterling Money to him in hand well and truly paid by the said John Thomas Junior at and before the sealing of these presents the receipt and payment whereof the said Josiah Culbertson doth hereby acknowledge, and therewith to be well satisfied and paid. hath Granted bargained and sold, and by these presents, doth grant, bargain, sell, alien, Convey and confirm unto the said John Thomas Junior his heirs and assigns all that Plantation Tract or parcel of Land Containing two hundred Acres. Situated on the North side of the South Fork of Sugar River above the ancient Indian boundary, bounding North on lands laid out to John Thomas and on all other sides by vacant land when laid out and hath such shape form and marks as is represented by a plat of the said Tract of land annexed to the Grant thereof which said land was Granted to the said Josiah Culbertson by a Grant bearing date the Sixteenth day of July. in the Year of our Lord One Thousand seven hundred and Eighty four. under the hand of Benjamin Guerard Esquire then Governor of the State aforesaid, and the great seal of the said State which said Grant was duly Recorded in the Secretarys Office of the State aforesaid and Reference being thereunto had may more fully appear together with all and singular the houses out houses buildings of all kinds, woods underwoods
