part. Witnesseth that for and in consideration of the sum of One hundred and
Eighty Three pounds Sterling to him the said John Norwood in hand paid by the
said Joseph Hughes at or before the sealing and delivery of these presents the
receipt whereof is hereby acknowledged by the said John Norwood doth hereby
release, quit, discharge the said Joseph Hughes his heirs administrators
and assigns by these presents do bargain sell and alien ^{remise} release convey and
confirm unto the said Joseph Hughes his heirs Executors Administrators
and assigns by these presents that tract or parcel of land lying and being in
Greenville County on the North side of the South Fork of Saluda about a mile
above the forks, beginning at Hickory running N E on lands laid out to Col: Anderson Esq: on vacant land. On lands the owner not known N W on
vacant land when surveyed and hath such shapes forms and marks as ap:
pears by a plat and grant thereunto annexed being granted by his Exel:
Lover Benjamin Guerard to the said John Norwood bearing date the 1st July
day the 16th day and the year of our Lord 1784 and in the ninth year of Anne:
Queen of Great Britain the said tract and grant being duly recorded in the Sec:
retaries office of said State reference therunto being had may more fully
