Twenty first day of February in the year of our Lord one thousand Seven hundred
 and Ninety between Edmund Peters of the county of Greenville and State of
 South Carolina of the one part and Gibson Suther of the State and County
 aforesaid of the other Part witnesseth that Said Edmund Peters for and in Consider-
 ation of the Sum of Thirty Pounds Sterling money to me in hand paid the
 Said Edmund Peters hath bargained and sold and by these presents doth bargain
 and sell make over and convey unto the Said Gibson Suther his heirs Ext.
 Adm^r one certain Tract or parcel of land containing one hundred acres Situate
 lying and being in Greenville County on Beaver-dam Creek of Enoree Including
 the farm whereof the Said Edmund Peters now lives on both Sides of the Said Bea-
 ver-dam Creek begining at a Stake or Red bat Station from thence to a post Oak
 corner Joining Rogers Wood from thence to a Hycory corner and to a Stake a dividing
 line and from thence to the begining Stake on Savages line To have and To hold the
 Said Tract or parcel of land and premises above mentioned with the appertaininges
 unto the Said Gibson Suther his heirs Ext. Adm^r and assigns for ever and the Said
 Edmund Peters for himself his heirs Ext. Adm^r doth Covenant to and with the Said
 Gibson Suther his heirs Ext. Adm^r and assigns a good Right full and lawfull
 Authority to grant let and Convey the same and that the said is free and clear
 from all Incumbrances whatsoever warranting the same not only against
 himself but all other persons having or may have any Right therunto
