 s^r Andrew Thompson & Jean Thompson his wife for & in consideration of the sum of
 Fifty pounds lawful money of the state of S. Carolina to them in hand paid by
 the s^r Robert Morrow at & before the sealing & delivery of these presents the Re-
 ceipt whereof is hereby acknowledged hath Granted bargained aliened Released &
 confirmed & by these presents doth Grant bargain sell alien Release & confirm un-
 to the s^r Robert Morrow in his actual possession now being by virtue of a bargain
 & sale to him thereof made for ever from the day of the date hereof & by force of
 the statute for Transferring uses into possession & to his heirs & assigns for ever
 all that plantation Tract or parcel of Land containing Two Hundred acres
