The following deed of conveyance from David Humphrey to Thomas Whitman with a plat annexed was presented in Court & proven by the oath of John Thomas Jun^r & Ordered to be Recorded which was done 10th March 1791

This Indenture made the ninth day of June in the year of our Lord one thousand seven hundred & eighty eight between David Humphreys of curry County in the state of North Carolina of the one part, & Thomas Whitman of Greenville County & state of S^c Carolina of the other part witnesseth that the said David Humphreys for & in consideration of the sum of Twenty five Pounds Sterling Money to him well & Truly paid by the said Thomas Whitman the Receipt whereof the s^r David Humphreys doth hereby acknowledge & to be fully satisfied & paid he the s^r David Humphreys hath Granted bargained & sold & by these
