


At and before the sealing and delivery of these presents the Receipt of which the said Joseph Reed doth acknowledge and thereof and of and from every part and parcel thereof doth acquit and discharge the said William Nicholson his heirs and assigns & divers other goods causes & considerations hereunto Moving have Granted Bargained sold Alien Enfeoffed and Confirmed & by these presents doth Bargain Sell alien Enfeoff and confirm unto the said William Nicholson his heirs & assigns for ever Part of a certain Tract of Land containing three hundred and thirty acres Originally Granted unto the said Joseph Reed and signed by his Excellency William Moultrie on the fifth day of June 1786 situate in the district of Ninety six on both sides of Rocky Creek a Branch of Rocky River Beginning on a Stake on the West side of Rocky Creek & Running South by a long conditional line of marked Trees to a Corner on a stake thence S^o by W^o along the dividing line to a corner on a post Oak thence S^o by W^o along the Original line to the corner on a white Oak thence S^o by E^o to the beginning including one hundred acres Together with all and singular the houses but Houses ways waters paths passages Trees Fences Easements Hereditaments & appurtenances whatsoever to the said parcel of Land so described belonging or in any wise appur- taining and the Reversion and Reversions, Remainder & Remainders, Rents, Issues, & profits thereof and every part & parcel thereof & all the estate Right Title Interest Claim and demand whatsoever both in law & Equity of the said Joseph Reed of in and to the said premises & of in to every part and parcel thereof To have and to hold the said parcel or part of the said Tract of Land and all and singular other the premises above mentioned with the appurtenances unto the said William Nicholson his heirs & assigns for ever; and Lastly the said Joseph Reed for himself his heirs the said one hundred acres of Land and all & singular the premises above Granted with their appurtenances unto the said William Nicholson and his heirs and assigns against all persons whatsoever shall & will warrant and for ever defend In witness whereof the said Joseph Reed doth hereunto set his hand and seal the day & year first above written Signed Sealed and delivered


