The following act of conveyance from the effects to ~~William Rea~~
 Reuben Brown was acknowledged before James Garrison Esquire produced
 in Court and Ordered to be Recorded which was done this 25th March 1791

This Indenture made this tenth day of February one thousand seven
 hundred and ninety one between the effects of Ninety six District & Green-
 ville County of the one part, and Reuben Brown of said County of the other part
 witnesseth that the said effects for and in consideration of the sum of
 Thirly pounds lawful sterling money to him in hand well and truly paid
 by the said Reuben Brown at & before the sealing and delivery of these pre-
 sente the receipt whereof is hereby fully acknowledged have granted Bargain
 and sold alighted Released and confirmed and by these presents do Grant
 Bargain alien Release and confirm unto the s^r Reuben Brown his heirs and
 assigns for ever all that part of a certain Tract of Land lying and being in the
 County of Greenville on Horse Creek waters of Reedy River Originally
 Granted unto the said effects and signed by his Attorney William
 Moore on the 1st day of May 1786 for 440 Acres all that part of the s^r
