The following deed of conveyance from William Lynch to Bright Pruett was
 produced in Open Court and acknowledged by the S^r William Lynch and ordered
 to be recorded which was done this 28th day of March 1791

This Indenture made this Twenty first day of February in the year of our Lord
 one thousand seven hundred and ninety one between William Lynch on the one part
 and Bright Pruett on the other both of the State of S^c Carolina and Greenville County
 witnesseth that the S^r William Lynch for & in consideration of the sum of one hundred
 pounds Sterling to him in hand paid the Receipt and payment whereof is hereby
 fully acknowledged, hath given Granted and sold and by these presents doth
 give Grant bargain and sell alien and release convey and confirm unto the S^r
 Bright Pruett his heirs and assigns forever a certain Tract or parcel of Land situ-
 -ate lying and being in the State and County afores^d on the sink hole fork of Tyger
 River joining land laid out unto Edmund Bearden and William Davis beginning
 on a Sycory and running N. 56 W. 53-70 to a post oak thence S 00 22-30 to a Sycory
 thence S 50 E 53 ch. to a red oak thence S. 63 E 19 to a chesnut thence to the beginning
 containing eighty nine acres Granted unto the S^r William Lynch by letters
 -patent bearing date the Twenty first day of January one thousand seven hun-
 -dred & eighty five and duly recorded in the Secretarys Office in Grant Book
 C. C. C. Page 304 as by Reference therunto had may more fully appear and
 at large appear Together with all woods ways waters and water courses build-
 -ings Improvements and appurtenances whatsoever unto the same belonging
