The following deed of Conveyance from Martin Gollothan & Nancy his wife to Andrew Jones was produced in Open Court and acknowledged by the s^r Martin Gollothan & ordered to be Recorded, which was done this 29th March 1791 —

This Indenture made the 19th day of February one thousand seven hundred & ninety one & in the fifteenth year of the united States of America between Martin Gollothan of Greenville County of the state S^t Carolina, of the one part & Andrew Jones of the other part of the County to State aforesaid witnesseth that Martin Gollothan for & in consideration of the sum of sixty Pounds to him in hand paid by the s^r Andrew Jones the Receipt whereof the s^r Martin Gollothan doth hereby acknowledge, In the s^r Martin Gollothan hath Granted Bargained & sold aliened & confirmed & by these presents doth Grant Bargain & sell alien & confirm unto the s^r Andrew Jones his Heirs & assigns for ever all that Plantation or Tract of land containing one hundred & Twenty three acres of land be the same more or less situate in the County aforesaid on Horse Creek a poplar bottom branch waters of Reedy River beginning on a red oak 34' 50" to a stake thence S 80 E to a stake 34' 47-50 thence N 16 E to a Beech 32-00 thence N 61 W to the Beginning Granted on the third day of October Recorded in the Secretarys Office Grant Book No. 10, page Reference being thereto had may more fully appear; and also all lands trees, woods under woods & other commons common of pasture profits commodities, advantages hereditaments ways waters and appurtenances whatsoever to the s^r Andrew Jones his Heirs & assigns above mentioned belonging or in any wise appertaining & also the Reversion and Reversions, Remainder & Remainders Rents & Services of the s^r premises of every part thereof & also all the estate Right Title Interest Claim to demand whatsoever of them the s^r Martin Gollothan for in & to the s^r plantation or Tract of Land computed one hundred & Twenty 3 acres be the same more or less of every part thereof to have & to hold the s^r tract of one hundred & Twenty 3 acres of Land & all & singular the premises above mentioned with every part & parcel thereof with the appurtenances unto the s^r Andrew Jones his Heirs & assigns for ever to the said Martin Gollothan for himself & his Heirs & assigns to the only proper use & behoof of him the s^r Andrew Jones his Heirs & assigns for ever to the s^r Martin Gollothan for him & his Heirs the s^r tract of one hundred & Twenty 3 acres by computation (be the same more or less) with the appurtenances to every part thereof against them & their Heirs & against all & every other person or persons whatsoever to the s^r Andrew Jones his Heirs & assigns shall & will warrant & for ever defend by these presents In witness whereof the s^r Martin Gollothan hath hereunto set his hand & seal the day and year first above written.
