

This Indenture made this fourteenth day of August in the year of our Lord
 Christ one thousand seven hundred & ninety between Samuel Brummitt of the
 County of Greenville & State of S^t. Carolina of the first Part & William Billingsby
 of the County & State afores^d of the second part Whereas in & by a certain Grant
 bearing date the seventh day of May anno Domini one thousand seven hun-
 dred & eighty seven & in the Eleventh year of the Independence of the United
 States of America from under the Hand of Thomas Pinckney Esq^r Governor &
 commander in chief in & over the S^t. State of S^t. Carolina & Great Seal of the
 same thereunto annexed & afores^d Give & Grant unto Samuel Brummitt a certain
 plantation or Tract of land containing three hundred & Seventy nine acres lying
 in the District of Ninety six on both sides of the main fork of Bear Creek off
 Saluda River bounding South East on Henry Woods & all other sides on
 Vacant land & hath such shape form & marks as appears by a plat thereof
 to the s^d Grant annexed as in & by the s^d Plat & Grant duly Recorded in the
 Secretarys Office in the S^t. State Reference being thereunto had will more
 fully appear & how this Indenture witnesseth That the s^d Samuel Brummitt
 & Ann Brummitt his wife for & in consideration of the sum of thirty pounds
 Sterling & money to the s^d Samuel Brummitt in hand paid by the s^d William
 Billingsby at & before the sealing & delivery of these presents The Receipt
 hereof the s^d Samuel Brummitt doth hereby acknowledge hath Granted
 Bargained and sold Released & confirmed by these presents doth Grant
 Bargain & sell Release & confirm unto the s^d William Billingsby a certain
 plantation or Tract of Land containing two hundred acres it being part
 of the above mentioned Tract of three hundred & seventy nine acres situate
 lying & being in the S^t. County of Greenville and bounded as followeth
 Beginning at Henry Woods line at the fork of the S^t. Creek including the left
 Hand fork of the S^t. Creek from the s^d Brummitts line to the dividing Ridge
 between the two prongs of the S^t. Creek together with all houses woods & under
 woods ways waters & water courses profits commodities privileges advantages
 & appurtenances whatsoever to the s^d land & premises belonging or in any
 wise belonging or appertaining & the Reversions &余地 Rents
 Issues & profits thereof and all deeds writings & entries touching or
 concerning the s^d lands & premises to have & to hold the s^d land hereby
 bargained & sold to the s^d William Billingsby his Heirs & assigns for ever
 & the s^d Samuel Brummitt for himself his Heirs & assigns doth hereby
 Covenant Grant & agree to be with the s^d William Billingsby his Heirs and
 assigns in manner following that is to say at the time of executing of these
 presents he the s^d Samuel Brummitt doth stand seized & possessed of a good sure
 perfect absolute & indefeasible Estate of Inheritance in fee simple in the
 hereby bargained & sold lands with and every the appurtenances thereunto belong-
 ing & that the s^d William Billingsby his Heirs & assigns may & shall from time
 to time & at all times hereafter have hold occupy possess & enjoy all & singular
 the hereby bargained & sold land and premises with the appurtenances to the
 the s^d Samuel Brummitt his Heirs & assigns shall & will warrant at any
 reasonable time hereafter make & execute any other deed or conveyance as
 the s^d William Billingsby or his Heirs shall reasonably require for the better
 securing the Rights of the s^d Land in fee simple to him the s^d William Bil-
 lingsby & his Heirs & assigns and to the true performance of all manner things
 Covenants herein contained to the s^d Samuel Brummitt his Heirs & assigns
 & hereby warrant & for ever defend the Right and Title of the s^d Land
 and premises hereby bargained and sold against the claim or demand
 of all & every other person or persons whatsoever that may or shall set up
