The following deed of Conveyance from Abner Senter to Joshua Goznell being proven before Reuben Barretto Esq^r by the oath of Jonas Dawson was presented & Recorded this 17th day of April 1795

This Indenture made this eighteenth day of October one thousand seven hundred and ninety four between Abner Senter in Greenville County South Carolina of the one part & Joshua Goznell of the County aforesaid of the other part Witnesseth that for & in consideration of the sum of twenty pounds Sterling Money to him in hand paid by S^r Joshua Goznell the receipt whereof is hereby fully acknowledged & that he the said Abner Senter for himself his heirs & assigns hath bargained & sold and by these presents doth grant bargain & sell alien release confirm & convey unto the said Joshua Goznell his heirs, Ex^{ors} Adm^{rs} & assigns for ever, a certain tract or parcel of land containing two hundred acres more or less situate lying and being on a small Branch of Sawtooth River including a large pile of Rocks on Clafuey Mountain having marks & shapes as is described in the plat beginning on a stake at N^o 25 ft to Dogwood 3, N^o 1 by cory 8, 80 to Spanish oak 3 + 6 25 to poplar 3, then to Chesnut oak 3, then to Chesnut 3 + N^o 80 to Chesnut 3, E 10 to Sawwood 3 then to Stake 3 + 35 to hycory 3 E 30 to Stake 3 + 85 to B. o. 3 ft 63 to the beginning corner Together with all woods waters water courses and conveniences with all Improvements profits Interests to the same belonging with all the rights members & every part & parcel thereof unto the said Goznell his heirs and assigns for ever to have and to the S^r tract of 200 Acres of Land more or less unto the proper use and behoof of him said Joshua Goznell his heirs and assigns The said Abner Senter for himself his heirs his Adm^{rs} & assigns shall and will warrant and for ever defend the above bargained premises against all persons whatsoever lawfully claiming any right or title to the same or any part thereof In witness whereof he said Abner Senter hath set his hand and seal this day and year above written
