The following deed of Conveyance from Enoch Hooper to William Thurston being proven before William Mitcheson Esquire by the oath of John Blackwell was presented and Recorded this 12<sup>th</sup> day of June 1795  
 This Indenture made made this thirteenth day of September in the year of our Lord one thousand seven hundred and ninety four between Enoch Hooper of the County of Greenville and State of South Carolina of the one part, and William Thurston of the County and State aforesaid of the other part, Witnesseth that the said Enoch Hooper for and in
