The following Deed of Conveyance from Hugh Carter & Hannah  
 Carter his wife to John Robinson being proven before John Blasing-  
 ame Esq. by the oath of Wm. M. Clanchan was presented and Re-  
 corded this 25<sup>th</sup> day of January 1796

This Indenture made this Eight Day of May 1795 Between  
 Hugh Carter and Hannah his wife of the County of Greenville & State of  
 South Carolina of the one part and John Robinson of the County and  
 State aforesaid of the of the other part. Witnesseth that the said Hugh  
 Carter for and in consideration of the sum of Eleven pounds three ten  
 Shillings & four pence sterling money <sup>to him</sup> the said Hugh in hand paid  
 the Receipt of which he doth here by acknowledge & there with to be fully  
 Satis fied contented & paid hath granted bargained and sold by these  
 presents Doth grant bargain and sell unto said John Robinson and his heirs  
 Two hundred acres of land lying and being in the County of Greenville  
 on the long branch it being one half of a tract of Land
