

The following Deed from Joshua Fowler to Richard Jones being proven before Sa. Milgore Esq. by the oath of Solomon Jones was presented & Recorded this 26th day of January 1796

This Indenture Made this ^{Seventeenth} Day of May on the year of our Lord 1794 of the sovereignty and independance of the united states of America the nineteenth between Joshua Fowler of pendleton County & state of south Carolina planter of one part & Richard Jones of Greenville County and state aforesaid planter of the other part where as in & by a certain Grant bearing Date the 7 Day of January 1793 Recorded in grant book F. No. 5 Page 435 signed by W^m. Moultrie then governor and commander in & over S^t State did give and grant unto Joshua Fowler a tract of land on Durbins Creek containing 27 acres Now this indenture witnesseth that he the S^d Joshua Fowler hath for and in consideration of ten pound Sterling to him in hand paid by the S^d Richard Jones the receipt whereof is hereby acknowledged bargained & sold & by these presents both bargain sell aline make over convey and confirm unto the S^d Richard Jones all the above mentioned tract of 27 acres of land situate in Greenville County on the waters of Durbins Creek the waters of Enoree river beginning at a. S. . O. : running S. 26. W. 17. Ch. to a stake thence S. 65. W. 15 Ch. to a. S. . O. thence S. 30. E. 17 Ch. to a hickery thence S. 65. E. 15 Ch. to the beginning to include 27 acres of land as aforesaid together with all & singler the appurtenances thereunto belonging or in any wise appertaining unto the only proper and appropiate use & be hof of him the S^d Richard Jones his heirs & assigns ^{and} he the S^d Richard Jones his heirs or assigns shall occupy possess & enjoy the S^d plantation or tract of land Free and Clear from any manner of hindrance. In witness whereof he the S^d Joshua Fowler his heirs exec^r. adm^r. or assigns and lastly he the S^d Joshua Fowler from himself his heirs exec^r. adm^r. and assigns or any other person or persons whosoever unto the S^d. Richard Jones his heirs executors adm^r. & assigns S^d tract of 27 acres of land as aforesaid will warrant & forever Defend in witness whereof he the S^d Joshua Fowler hath here unto set his hand seal the Day and Date first above written in.
