The following Deed of Conveyance from Nicholas White to George
 Hanegim being proven before James Helgou Esq^r by the oath of
 James Halls was presented & Recorded this 22nd day of Sept^r 1796
 This Indenture made this 22nd day of March 1796 between
 Nicholas White planter of the one part, & George Hanegim plan-
 ter of the other part both of the state of South Carolina Greenville
 County Witnesseth that the s^r Nicholas White for & in considera-
 tion of the some of one hundred pounds lawful money to him
 in hand paid by the s^r George Hanegim the receipt is hereby
 acknowledged, the s^r Nicholas White doth bargain sell & convey
 unto the aforesaid George Hanegim a certain tract or parcel of
 land containing one hundred acres more or less, lying & being
 in the state & County aforesaid & on the North side Durbins creek
 the waters of Enore river & is bounded as follows on the N.
 by Fairs land, on the S. by the s^r Whites land, running with s^r
 Whites line to Thomas Nations line on the Wth side along s^r
 line to a conditional corner on a white oak, the branch s^r Na-
 tions line on the Wth side up s^r branch the various courses of s^r branch
 to another conditional corner on a Maple at the fork of s^r branch
 thence up the s^r hand fork on a conditional line to a black
