The following Deed of Conveyance from Sam<sup>l</sup> Walker to Jesse Smith being proven before Horatia Griffin Esq<sup>r</sup> by the oath of John Walker was presented and Recorded this 3<sup>rd</sup> day of April 1879

This Indenture made this sixth day of November in the year of our Lord one thousand seven hundred and ninety one and in the fifteenth year of the Independance of the united States of America between Samuel Walker of Greenville County State of S<sup>c</sup> Carolina of the one part & Jesse Smith of the County State aforesaid of the other part whereas by a certain grant bearing date the fifth day June one thousand seven hundred & eighty six from under the hand of his Excellency William Moultrie Esq<sup>r</sup> Governor and commander in chief in & over the said State having the great seal of the State thereunto affixed being for that purpose appointed did give & grant unto the said Samuel Walker a plantation or tract of land containing one hundred and twenty eight acres situate lying in Greenville County on Rocky Creek of Enore River and hath such form & marks bullings and boundings as appear by a plat thereunto annexed which said plat & grant being duly Recorded in this Secretarys Office in Grant Book N N N N page 142 reference being thereunto had may more fully appear Now this Indenture witnesseth that the said Samuel Walker for and in consideration of the sum of sixty pounds current money of S<sup>c</sup> State to him in hand well & truly paid by the said Jesse Smith before the sealing and delivering of these presents, the receipt whereof is hereby acknowledged hath granted bargained & sold and by these presents do bargain sell and convey unto the said Jesse Smith the above described tract of land Together with all woods watas hereditaments & appertinances unto the said land belonging or in any wise appertaining and reversion & reversions, remainds & remainders rents Issues & profits thereof to have and to hold the granted premises of one hundred & Twenty Eight acres of land unto the S<sup>r</sup> Jesse Smith his heirs Ex<sup>rs</sup> Adm<sup>rs</sup> or assigns for ever & that the S<sup>r</sup> Samuel Walker his heirs Ex<sup>rs</sup> Adm<sup>rs</sup> & the covenants & agree to & with the S<sup>r</sup> Jesse Smith his heirs Ex<sup>rs</sup> Adm<sup>rs</sup> or assigns shall at all times hereafter peaceably & quietly occupy possess & enjoy the ~~tract~~ of one hundred & Twenty Eight acres of land lying & being as aforesaid from all former bargains sales Mortgages Judgments Rights & dowaries, and all other Incumbrances whatsoever What the Samuel Walker his heirs Successors will warrant & for ever defend the S<sup>r</sup> Jesse Smith one hundred and twenty eight acres of land unto the S<sup>r</sup> Jesse Smith his heirs Ex<sup>rs</sup> Adm<sup>rs</sup> or assigns from all and sundry that may lay any claim or demand upon the said land or the said Jesse Smith or his heirs or assigns that may
