



in his actual possession now being one tract of land containing one hundred acres be the same more or less lying and being on the East side of Enoree River and in the county of Greenville it being part of a Tract Originally granted to the said Robert McAfee & Isaac Green said grant signed by his Excellency W^m Moutrie and bearing date the seventh day of April one thousand seven hundred and ninety four, recorded in grant book N^o 5 page 180 the said tract of one hundred acres be the same more or less contained in said Grant on the East side of Enoree river beginning on a post oak George Persons corner, thence down the river as it meanders to Robert Goodletts line, and corners line thence with Connors line to the Eastern line of McAfee's & Green's & thence along said line N^o 50 to a post oak corner thence S^o 50 to a pine, thence to the beginning the same containing one hundred acres be the same more or less it being the whole of the afo^r survey that is on the east side of Enoree River and that is found to be out sides of Robert Goodletts Survey, with all and singular the houses buildings Gardens, Orchards Trees, woods, under woods tithes commons commons of pasture profits, commodities hereditaments, ways waters, water Courses and appurtenances whatsoever to the same belonging or in any ways appertaining and also the reversion and reversions remainder and remainders rents Issues and profits to the same belonging or in any ways appertaining and all the estate right title Interest dower claim and demand whatsoever of them the said Robert McAfee & Isaac Green of in & to the s^d bargained premises and every part and parcel thereof to have and to hold the said bargained premises to the s^d Gibson Southern his heirs and assigns for ever & the s^d Robert McAfee and Isaac Green their heirs & assigns the said tract of land against them their heirs & assigns and will warrant and for ever defend by these presents unto the said Gibson Southern his heirs & assigns and from all and every other person & persons whatsoever lawing lawful claim thereunto In witness whereof the s^d Robert McAfee & Isaac Green have hereunto set their hands & seals the day and year above written

The following Deed of Conveyance from William Griffin Turner to Benjamin Turner being proven before Robert McAfee Esq^r by the oath of Charles Benson was presented and recorded this 10th day of June 1797

State of South Carolina I know all men by these presents that I William Griffin Turner of Greenville County & State aforesaid in consideration of the sum of ninety five dollars to me paid by Benjamin Turner of the County and State aforesaid have granted bargained sold & released unto the said Benjamin Turner all that Tract of land where the s^d Benjamin now lives containing one hundred acres more or less situated in Greenville County on the north side of Saluda River it being part of a Tract of land
