The following Deed of Conveyance from Nicholas White to James Nicks being proven before James Kellogg Esq^r by the oath of Thomas Nation was presented and recorded this 18th day of June A.D. 1797

This Indenture made this 20th day of August one thousand seven hundred and ninety six, and in the twenty first year of Americans Independence, Between Nicholas White of Greenville County State of South Carolina planter of one part, and James Nicks of the State and County afores^d planter of the other part witnesseth that the s^rd Nicholas White hath for & in consideration of twenty pounds Sterling to him in hand paid by the said James Nicks the receipt is hereby acknowledged hath bargained, sold & released conveyed and confirmed and by these presents doth bargain sell convey and confirm unto the s^rd James Nicks a tract of land bounded to be one hundred acres be the same more or less in Greenville County on the north side Drubens Creek the waters of Enoree river it being part of a tract of land granted to the s^rd Nicholas White Recorded in Book F page 5 N^o 507 and sold to George Flanigan and is bounded as follows beginning at a conditional corner made by the said Nicholas White & George Flanigan on the branch Thomas Nations now lives on the corner being on a map thence along a conditional line to a black gum corner on Thos. Nicks line & thence along said Nicks line to William Pecknalls corner thence along said
