 of October 1786 by his Excellency William Moultrie then governor the
 Land situate in Greenville County bounding on the N.W. by Sarah Roberts
 Land and Joseph Sanders Land and to the S.E. by Chuchwell Tracts on
 Land, and hath such shape form and marks as appears from a
 plat annexed to said Grant (Exhibit) the said John Peck doth covenant
 & agree to and with said Samuel Kelly that he will for ever warrant
 and defend the above described Land with all its appurtenances rents
 Issues profits commodities hereditaments orchards buildings & Dams
 whatsoever thereunto belonging or in any wise appertaining thereunto
 from himself his heirs Executors Administrators or assigns or any
 other person or persons whatsoever laying any Just or lawful right
 title or claim thereunto or any part thereof but to the only proper use and
 behoof of him the said Samuel Kelly his heirs Executors Administrators or
