

This Indenture made the twenty ninth day of November and in the year of our Lord one thousand seven hundred and ninety two between Hugh Lewis of North Carolina and Tenney County of the one part, and John Young Junr. of the State of South Carolina & Spartanburg County of the other part witnesseth that the said Hugh Lewis for and in consideration of the sum of thirty pounds sterling Money to him the said Hugh Lewis in hand well and Truly paid by the said John Young Junr. the receipt whereof is hereby acknowledged by the said Hugh Lewis hath granted bargained, sold, aliened, released, conveyed and confirmed, and by these presents doth grant, bargain, sell, alien, release convey and confirm unto the said John Young Junr. his heirs and assigns for ever in his actual possession now being all that plantation, Tract, or parcel of land containing two hundred and thirleen acres by the same more or less situate lying and being in Greenville County and State of South Carolina on both sides of Claytons branch of Reddy river begining on a post oak on Williams Youngs line thence running S 65 W 9 ch. to a post oak thence S 55 W 53 ch. thence N 42 E 11 ch. to a stake by a post o thence North 47 ch. 20 links to a red oak thence, N 45 E 30 ch. to a stake, thence N 70 E 9 ch. 80 links on the aforesaid William Youngs line to a Hickory thence S 20 W 32 ch. 90 links to a stake said Wm Youngs Corner thence to the begining granted to the said Hugh Lewis by a Grant bearing date the fifth day of Sept. one thousand seven hundred and eighty five, together with all and singular the houses out houses gardens Orchards Trees woods profits advantages hereditaments ways waters and appurtenances whatsoever to the same belonging or in any ways appertaining and also the Reversion and reversions, re- mainder and remainders rents Issues and profits to the same belonging or appertaining and all the Estate right Title Interest dowers and rights of dowers claim and demand whatsoever of him the said Hugh Lewis of in and to the said tract of land and premises and every part and parcel thereof to have and to hold the said bargained premises and all and singular the said premises above mentioned and every part and parcel thereof with the appurtenances unto the said John Young Junr. his heirs & assigns to the only use and behoof of him the said John Young Junr. his heirs and assigns, and the said Hugh Lewis for himself and his heirs the said Tract of Tenament and premises and every part thereof again st him the said Hugh Lewis his heirs Executors and Administrators shall and will warrant and forever defend by these presents unto the said John Young Junr. his heirs and assigns from and against all and every person or persons whatsoever laying any lawful claim thereunto In witness whereof the said Hugh Lewis hath hereunto set his hand and affixed his seal, the day and year first above written.
