 to whom the land was granted by his Excellency Benjamin
 Guano Esq^r bearing Date the fifteenth day of October on thou-
 sand seven hundred eighty five being one hundred acres more or
 less beginning adjoining Alexander Wests Land & to be laid off
 in an oblong square as most convenient together with all & singu-
