In the State of South Carolina Union County Anowall man by these Presents that John Sanders, Recat late to being made power attorney of Union County for and In consideration of Two Hundred Dollars to in hand paid by James Lewis of Greenville County State aforesaid I have granted, Bargained & sold & Released and by these presents do Bargain sell & Release unto the said James Lewis off Greenville County State aforesaid that all that Tract or Parcel of Land containing Two Hundred & fifty Acres situate in Greenville County State aforesaid on both Sides of Peters Creek Waters of Enoree River bounded as follow on the N^o by Reuben Smith on the W^o by said Lewis own land on the E^o by Sam'l Kelly and on the S^o by Isaac Towns Land and hath such Shaps & Marks as doth appear from a Plat annexed to a Grant in the name of Joshua Sanders for the aforesd 250 Acres Bearing Date the first Day of January in the year of our Lord 1785 and Recorded in Grant Book (6666) page (354) together with all and singular the rights Members Hereditaments and Appurtenances to the said Premises belonging or in any wise appertaining or incident to have & to Hold all & singular the premises before Mentioned unto the said James Lewis his Heirs and Assigns forever and I do hereby bind myself my Heirs Executors

The following Deed of Conveyance from Frederick Farmer & Sally Farmer to Samuel Roberts being proven before Humphrey Cobb Esq^r by the oath of Hugh Brumby was presented and Recorded this 25th Day of June 1798
This Indenture made this the twenty fourth Day of October on the year of our lord one thousand seven hundred Ninety & in the twenty first year of American Independence between Frederick Farmer & Sally his wife of the County of Greenville & State of S^t Carolina of the one part & Samuel Roberts of the other County & State aforesaid of the other part Witnesseth that the said Fred^r Farmer & Sally his wife for and in consideration of the sum of one hundred pounds Sterling to them in hand paid at or before the sealing & delivery of these presents the receipt whereby acknowledged the said Frederick Farmer & Sally his wife hath given granted & Sold Alined & Confirmed & by these presents doth give grant bargain sell & conform unto the said Sam^r Roberts his heirs certain Tract or parcel of Land situated lying & being in ninety six Rods & containing one hundred acres more or less it being part of one hundred & seventy acres surveyed & granted to John Waltrip by this Excellency William Moultrie the fourth Day of February on thousand seven hundred & ninety three laying on Rocky Creek a branch of the Golden Grove beginning at the Mouth of a branch that runs through the field where David Jones now lies therein along the line first run round the said land to the corner staking thence to a post oak corner thence to a post oak corner there also a conditional line of William Thompson on thence along the line to a red oak corner thence along the ridge road to David Jones conditional line to the end of the branch all the beginning to gether with all & singular the rights &
