Line thence to an east corner on a post oak thence to a N. E. corner thence along the line to a conditional line made between the ^{to} Waldroop and Farmer to the beginning on the pine as will more fully appear by a plat annexed to the aforesaid grant and Recorded in grant book E. The State of South Carolina Know all men by these presents that James Brock of Greenville County in the State aforesaid in consideration of the sum of thirty pounds to me paid by Samuel Magnis of the County in the State aforesaid have granted Bargained sold and Released and by these presents do grant Bargain sell and Release unto the said Samuel Magnis a certain tract of Land containing one hundred and Eighty seven acres more or less being part of a tract of Land granted to James Nelly Dated the Ninth Day of November one thousand seven hundred and Eighty Six by his Excellency William Moutree Governor beginning upon the North line and pine stump running South to a post oak a conditional line made by the parties thence the Original line to a hickory corner thence the Original line to a red oak corner thence to the beginning together with all and singular the Rights members hereditaments & appurtenances to the ^{to} premises belonging or in anywise Incident or appertaining to have & to hold all & singular the premises before mentioned unto the ^{to} Samuel Magnis his heirs & assigns forever & also here by signed myself heirs Executors & Administrators to warrant & for ever defend all & singular the said premises unto the Samuel Magnis his heirs & assigns against myself my heirs & assigns lawfully claiming or to claim the same or any part thereof in witness my hand this 7th Day of November One thousand seven hundred & ninety seven In the twenty first year of the Independence of the United States of America Signed in presence of us Henry Brock David Brock Wm German James Brock
