

The following deed of conveyance from William Green to Ambrose
 Hammond being proven before Humphrey Cobb Esq^r by the oath of
 William Arroy was presented and recorded this 29th day of April 1799
 South Carolina This Indenture made the fifth day of
 February one thousand seven hundred and ninety eight Be-
 tween William Green Sean Green of Greenville County and
 State aforesaid of the one part and Ambrose Hammond of the
 same place of the other part Witnesseth that the said
 William and Sean for & in consideration of the sum of fifty
 pounds Sterling money to them in hand paid by the said
 Ambrose Hammond the Receipt whereof they do hereby
 acknowledge They the said William and Sean Green hath
 granted Bargained sold aliened in feoffed Release and
 confirmed and by these presents doth Grant Bargain
 Sell alien In feoff Release and confirm unto the said
