Know all by these presents that John McCormack  
of Greenville County & State aforesaid for and in considera-  
tion of the sum of three hundred Dollars to me in hand paid  
by John Champion of State & County aforesaid have  
Granted Bargain sold and released & by these presents do  
Grant bargain sell & release unto the said John Champion one  
hundred & fifty acres of Land out of a survey granted by  
Benjamin Guaradi Esq. unto Alexander Ray for three  
hundred Acres lying in Greenville County on the South side of  
Needy River beginning at the River running East to a post  
ack thence North fifty four Degrees seven by three to and back  
thence West Crossing the north fork to the south down the same  
as it meanders to the beginning containing as above one  
hundred and fifty acres with all & singular the rights here-  
unto and appertaining to the said premises be long in or  
in any wise incident or appertaining to have and to hold the said  
premises before mentioned unto the said John Champion his heirs  
& assigns forever and do here by being myself my heirs &c. to  
warrant & defend all & singular the said premises unto the  
said John Champion against the claim of myself my  
heirs & all other claim what ever with my hand and  
seal this 14<sup>th</sup> day of March in the year of our Lord one thousand  
seven hundred and ninety nine John McCormack

243 The following deed of conveyance from David Foster to Thomas  
Gazaway being proven before Heubin Barretto Esq. by the oath  
of John Davis was presented and recorded this 3<sup>rd</sup> day of June 1799  
This indenture made and concluded on this seventh day of  
February in the year of our Lord one thousand seven hundred  
& ninety nine Between David Forrester of the one part and  
Thomas Gazaway of the other part Both of Greenville  
County and State of Carolina It is shewed that David  
Forrester for and in consideration of the sum of Twenty Dollars  
to him in hand paid the Receipt whereof is here of fully acknow-  
ledged. By these presents said both bargain and sold &  
ertain Part of the said plantation that I the said David  
Forrester doth now live on being conditionally marked and  
bound as follows (viz) Beginning on a South East Corner of  
S<sup>d</sup> tract then running N. to the beginning Branch then down  
S<sup>d</sup> branch to where it enters itself in a branch of S<sup>d</sup> Sygar  
then up S<sup>d</sup> Sygar to a white oak corner of Land laid out  
to Mary Varney and thence to the beginning corner or  
locust containing seven ten acres and a half more or  
less unto the said Thomas Gazaway him his heirs Execu-  
tors & assigns by me the said David Forrester bind  
myself my heirs Executors &c. and Every of them to  
warrant & defend to defend the same against Every  
person or persons saying any Lawful Right Title Inte-  
rest or claim to said seven ten acres & half in Witness  
whereunto I have set my hand hand and affixed my seal  
the day and year first above written David Forrester
