for Tyre Glenn thence the same Course over Guildens Creek
to a stake corner on the West side of said line thence
said line S. W. E. to a corner on line of Enore River
thence up the Meanders of said River on the South side to a
Spanish Oak corner on the bank of said River old marked
for Christopher McCray thence on said McCrays line S. 30. W.
15° to a iron wood corner old marked for McCray thence up the
meanders Peters Creek to McCrays Chestnut corner thence
