The following Bill of Sale from Martin Whappy to David M'David being proven before Horatio Griffin Esq^t by the 10th of May 1799 was presented and record at this 23 June 1799 This Indenture made this the Twenty second day of October One thousand seven hundred and Ninety Eight Between Martin Whappy & David M'David both of the state of S Carolina County of Greenville Witnesseth that the said Martin Whappy for and in consideration of the sum of Seventy three Spanish Mills Dollars to him in hand paid by the said David M'David at or before the sealing & delivering of these presents the receipt whereof is hereby acknowledged by the said Martin Whappy hath Granted Bargained and sold & by these presents doth Grant Bargain & sell unto the said D. M'David his Heirs & assigns forever the following mentioned property viz one Brown Horse four Cows two Martars Cows & Calves six Head of Hogs two Beds & furniture two Turn wheels Chest Trunk and all the other House hold furniture that the said Martin Whappy am now possessed with also a set of Coopers tools one axe and Hatchet one Gun being here & one plow eight hundred feet boards with all the right title to claim & demand of the said Martin Whappy unto the said David M'David his Heirs and assigns forever as his or their title and property also
