Know all men by these presents that Adie Linn of Greenville County and State aforesaid plaintiff in consideration of the sum of one hundred & thirteen Dollars to me paid by William Linn of the County & State aforesaid plaintiff have granted bargained sold and released and by these presents do grant bargain sell & release unto the said William Linn all that parcel or tract of Land containing one hundred and thirteen acres situate in Greenville County in a branch of Mayboms Creek being part of a tract of Land containing two hundred & forty four acres originally granted to Samuel Nesbit Junr. by his Excellency Benjamin Guiard on the twenty first day of January one thousand seven hundred and eighty five beginning on a post oak & being the North west corner of the said tract and running thence N 55 E 35 Chains to a stake near a Oak thence S 85 E 27 Chains to a stake thence S 55 W 50 Chains to a stake thence S 55 W 4 Chains to a post oak & thence N 65 E 15 Chains to a hickory & from thence to the beginning together with all and singular the rights members hereditaments & appurtenances to the said premises belonging or in anywise incident or appertaining to have & to hold all & singular the premises before mentioned unto the said William Linn his heirs and assigns for ever I do hereby bind myself my heirs executors and administrators to warrant and for ever defend all and singular the said premises unto the said William Linn his heirs and assigns against myself and my heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof Witness my hand and seal this fifteenth day of June in the year of our Lord one thousand seven hundred and ninety nine and in the twenty third year of the Independence of the United States of America
