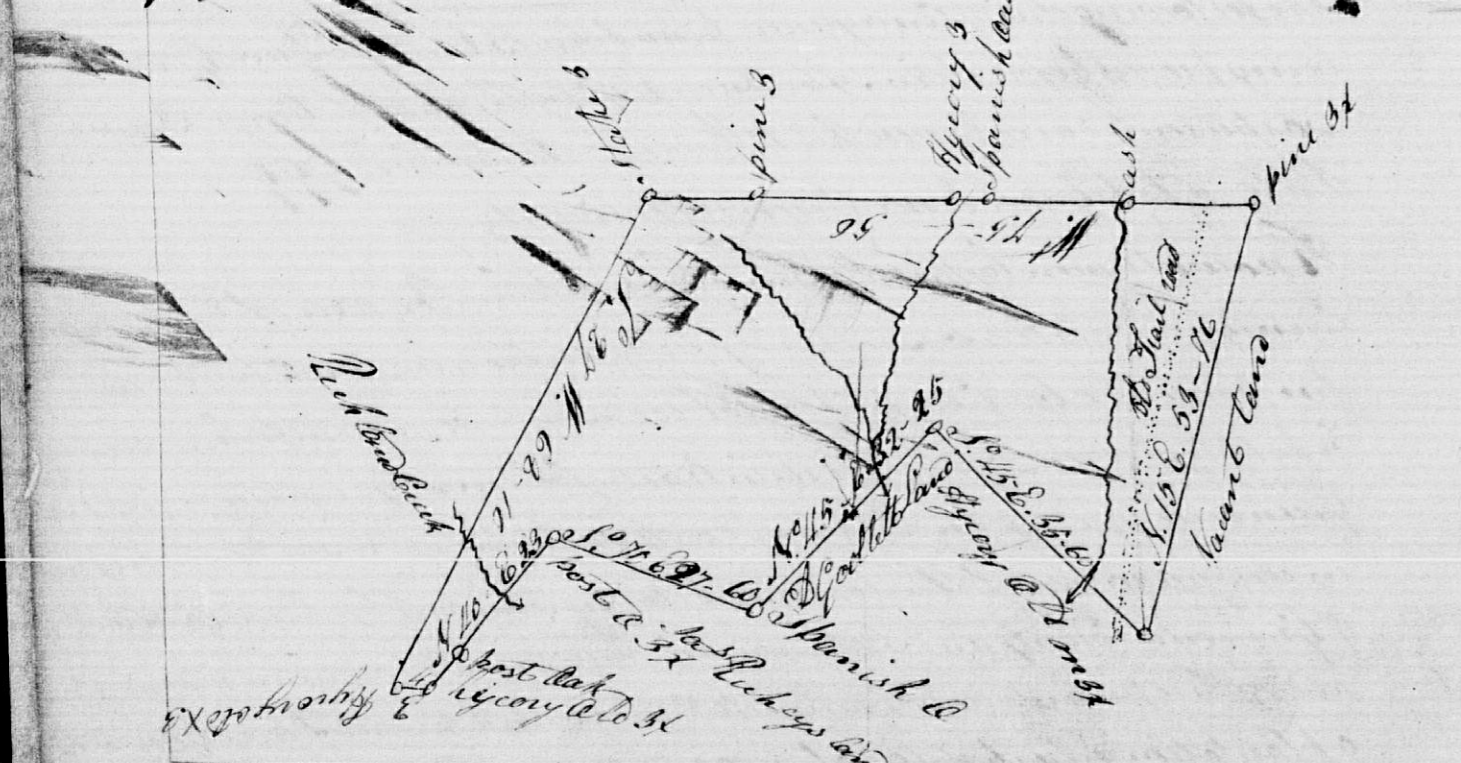

 I know all men by these presents that Jonathan Stone of Guilmer County in the State aforesaid in consideration of one hundred dollars to me in hand paid by Samuel Neighbors of Laurens County in the State aforesaid have granted Bargained Sold and Released and by these presents do Grant Bargain sell and Release unto the said Samuel Neighbors a tract of land containing seventy nine acres (be the same more or less) situate in Greenville County lying on Mountain Creek & Saluda River Beginning at said Creek at the mouth of a Branch at a State of running thence S. 35 W. 8 50 up S. Branch to a white Oak 31

317 thence S. 66 W. 9 75 to a stake at thence S. 6 11 12 to a white Oak 31  
 thence S. 82 E. 1 10 to a poplar 31 thence S. 72 E. 8 50 to Saluda River  
 thence Down the Meanders of said River S. 6 E. 9 22 to Bensons line  
 thence N. 56 E. 29 on the said line to Mountain Creek thence up the
