Know all men by these Presents that Jesse Baker of Greenville District in consideration of the sum of one hundred and twenty five Dollars to me paid by Laban Loftis of said District I have granted bargained sold and released and by these presents do grant bargain sell & release unto Laban Loftis a Plantation or Tract of Land lying & being in Greenville District and State aforesaid and on the Sixth hole fork of ^{Big} ~~Big~~ River joining said Land laid off to Edmond Barton & Wm Davis, being part of a Tract of Land granted to Wm Lynch on the twenty first day of January in the year of our Lord One thousand seven hundred & Eighty five beginning on a Locust marked ^{tree} H, running along the original line of said Survey, down to a hickory at the lower end of S. Leavins Tract, thence up the other side of said Survey joining land laid off to Barton to a green corner made on a White Oak, thence a small distance to a Red Oak, all original Corners of said Tract of Land thence a straight line across said Survey to the aforesaid Locust corner agreed on by the parties, containing by estimation fifty Acres more or less. Together with all & singular the rights members hereditaments & appurtenances to the said premises belonging in any wise appertaining. To have and to hold all & singular the Premises before mentioned unto the said Laban Loftis his heirs & assigns for ever. And I do hereby bind myself my heirs Executors & Adors to warrant and for ever defend all & singular the said Premises unto the said Laban Loftis his heirs and assigns against myself my heirs & against all & every other person whomsoever lawfully claiming or to claim the same in any part thereof.
