 eight hundred, between Clayburn Sullivan of the County of Greenville
 South Carolina of the one part and William Leaford of the County
 and State aforesd of the other part, Witnesseth that the s^rd Clayburn
 Sullivan for & in Consⁿ of the sum of one hundred dollars to him in hand
 paid the receipt whereof is hereby acknowledged he the said Clayburn
 Sullivan hath granted, bargained sold alien^d enfeoffed released
 Conveyed & Confirmed, and by these Presents doth grant bargain, sell
 alien enfeoff release Convey and Confirm unto the said William
 Leaford his heirs &c. for ever. A certain tract of land Containing —
 Fifty Acres more or less being a tract granted to said Sullivan by a
 Deed of Conveyance from John Swearingen reference being there had
 will more fully appear laying and being in the County aforesaid
 on the Beaver Dam Creek beginning at a Post Oak on Swearingens line
 thence S.W. 20° 22' & 50' to a White Oak 3+, thence on Isaac Farms line
 about 18° to a post oak 3+ thence on an agreement dividing line to a
 black, on Joel's line about 30'. thence on S. line about 18° to the
 begining. Together with the improvements, reversion, remainder, rent,
 issues and profits, and also all the estate right title claim & demand
 whatsoever of in & to the said land & premises and every part thereof with
 the appurtenances thereto appertaining: To have and to hold to the
 said William Leaford his heirs & Executors, Administrators & Assigns
 forever, to his and their only proper use benefit and behoof forever,
 and the said Clayburn Sullivan doth hereby grant that he will for
 ever warrant and defend the above bargained Premises unto the s^rd Wm.
 Leaford his heirs and assigns forever, against him the s^rd Clayburn
 Sullivan his heirs & Executors &c and all and every other Person claim-
 ing
