Know all men by these Presents that I Benjamin Kilgore Junr. of Greenville District in the State of aforesaid for and in consideration of one hundred Pounds Sterling to me in hand paid by James Kilgore of the State and District aforesaid, I the said Benjamin Kilgore Junior Have granted bargained sold and Released, and by these Presents do grant bargain sell and release unto the said James Kilgore his heirs and assigns forever, all that Tract or parcel of Land supposed to contain two hundred acres be the same more or less it being a part of a Tract of One thousand acres originally granted to the said Benjamin Kilgore Junr. by Patent bearing date the third day of September in the year 1792. and Recorded in grant book F. N. 5. page 149. Situate in the State and District aforesaid on the S. side of Enoree River, and on some branches of said river, Beginning on a post Oak Corner on the original line & John Deans line said Corner being made for Thomas Thomake, thence on S. line S 62 E. 60 ch. to a Stake Corner on James White's line, then on said line S 30 W. 51 ch. to a small red Oak Corner. Butlers Corner. Then on S. Butlers line N 49 W. 13. 30 to a Spanish Oak Corner on Weillbanks line, then on S. line N. 32 E. 20 ch. to a Post Oak Corner old made for S. Henry Weillbanks, then on S. line N. 72 W. 48. 50 to a Stake Corner of said Thomakes, then on a line through said Tract running N. 45 E. 42. 50 to the Beginning Post Oak corner. Also one other part of said original Survey beginning on a Stake Corner on the original line thence on said line S 79 W. 39. chains to a Stake Corner on the original line on Isaac Towns line, thence on said line N. 60 W. 14. 50 to a Stake Corner old made for John Mackaffy, then on said line N. 5 W. 19 ch. to a Pine Corner then N. 40 W. 37 ch. to a red Oak corner, then N. 18 W. 14 ch. to a red Oak corner, then due E. 70 ch. to a Stake corner on John Kitchens line, then on said line S 40 E. 12 ch. to a red oak corner, then on S.
